Recommend approval of resolution transferring \$3,685,826 from the MAPS 3 Convention Center budget to Project MC-0749, Oklahoma City RIVERSPORT Improvements, 800 RIVERSPORT Drive. Ward 7.

Location:

800 RIVERSPORT Drive

Background:

The MAPS 3 Whitewater Facility was completed in 2016. Additional improvements are needed prior to the 2028 Olympics. The Public Works Department is managing a contract for the improvements that includes a feasibility study, a master plan for future improvements, and replacement of the Unistrut system. The Unistrut system is an anchoring system at the bottom of the whitewater channels used to secure the RapidBlocs obstacles throughout the course.

The Public Works Department has requested funding assistance from the MAPS budget to assist with the project. MAPS recommends transferring \$685,826 for the feasibility study and master plan and \$3,000,000 for the Unistrut system from the MAPS 3 Convention Center budget to Public Works for the Oklahoma City RIVERSPORT design and improvements.

WHEREAS, the MAPS 3 Whitewater Facility was completed in 2016; and

WHEREAS, MAPS recommends transferring \$685,826 for the feasibility study and master plan and \$3,000,000 for the Unistrut system from the MAPS 3 Convention Center budget to Public Works for the Oklahoma City RIVERSPORT improvements.
