COUNT 1: EMBEZZLEMENT ~ 21 O.S. § 1451(B)(4), a FELONY

STATE OF OKLAHOMA, COUNTY OF PAYNE:

I, Laura Austin Thomas, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Payne and in the State of Oklahoma, **BRITT ALAN WEAVER** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: EMBEZZLEMENT ~ a FELONY, That is to say, the said defendant, between the **4th day of October, 2021 and the 5th day of May, 2022**, and in the County and State aforesaid, being then and there at all times the President of the Board of the Stillwater Pioneer Booster Club, a booster club sanctioned by the Stillwater Board of Education, and while acting in said capacity as President of the Board did knowingly, willfully, wrongfully and feloniously embezzle, convert and appropriate to his own use and benefit the total sum of \$23,580.00, belonging to the Stillwater Pioneer Booster Club, which money was appropriated for a specific purpose and which came into the said defendant's care and control by virtue of his position as President of the Board of the Stillwater Pioneer Booster Club, by presenting a series of counter checks to Simmons Bank in Stillwater Oklahoma, thereby circumventing the two-signature requirement for checks drawn on the Stillwater Pioneer Booster Club account causing him to be personally paid by the bank, specifically as follows:

On or about the 4th day of October 2021, the defendant submitted a counter check to Simmons Bank on the account of the Stillwater Pioneer Booster Club that was made payable to Cash and signed by the defendant in the amount of \$2,500.00, and the defendant received \$2,500.00 in cash belonging to the Stillwater Pioneer Booster Club;

On or about the 3rd day of November 2021, the defendant submitted a counter check to Simmons Bank on the account of the Stillwater Pioneer Booster Club that was made payable to the Pioneer Booster Club and signed by the defendant in the amount of \$46,342.00, and the defendant received \$3,500.00 in cash belonging to the Stillwater Pioneer Booster Club;

On or about the 17th day of November 2021, the defendant submitted a counter check to Simmons Bank on the account of the Stillwater Pioneer Booster Club that was made payable to the Pioneer Booster Club and signed by the defendant in the amount of \$11,500.00, and the defendant received \$2,500.00 in cash belonging to the Stillwater Pioneer Booster Club;
