Vicki Zemp Behenna, the District Attorney of Oklahoma County, Oklahoma,
informs the District Court, that:

- Count 1: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Assault And Battery With A Dangerous Weapon, a Felony, by unlawfully and willfully, wrongfully, and intentionally, without justifiable or excusable cause commit an assault and battery on one Enrique Abner Ajqui-Cotom with a certain dangerous weapon, to-wit: brass knuckles held in the hand of said defendant the same not being a dangerous weapon per se, but used by said defendant in a manner likely to produce great bodily harm to Enrique Abner Ajqui-Cotom and with which he struck the said Enrique Abner Ajqui-Cotom with force and violence, and did thereby inflict injuries on and about the head of the said Enrique Abner Ajqui-Cotom with the unlawful and felonious intent then and there to do him bodily harm, contrary to the provisions of 21 O.S. 645 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.
- Count 2: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Assault And Battery With A Dangerous Weapon, a Felony, by unlawfully and willfully, wrongfully, and intentionally, without justifiable or excusable cause commit an assault and battery on one Enrique Abner Ajqui-Cotom with a certain dangerous weapon, to-wit: a pistol held in the hand of said defendant the same not being a dangerous weapon per se, but used by said defendant in a manner likely to produce great bodily harm to Enrique Abner Ajqui-Cotom and with which he pistol whipped the said Enrique Abner Ajqui-Cotom with force and violence, and did thereby inflict injuries on and about the head of the said Enrique Abner Ajqui-Cotom with the unlawful and felonious intent then and there to do him bodily


harm, contrary to the provisions of 21 O.S. 645 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

- Count 3: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Feloniously Pointing Firearm, a Felony, by unlawfully and willfully, without lawful cause pointed a rifle at Enrique Abner Ajqui-Cotom for the purpose of threatening or with the intention of discharging the firearm or with any malice or for any purpose of injuring, either through physical injury or mental or emotional intimidation or for purposes of whimsy, humor or prank, or in anger or otherwise, contrary to the provisions of Section 1289.16 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
- Count 4: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Feloniously Pointing Firearm, a Felony, by unlawfully and willfully, without lawful cause pointed a rifle at Ruben Hernandez for the purpose of threatening or with the intention of discharging the firearm or with any malice or for any purpose of injuring, either through physical injury or mental or emotional intimidation or for purposes of whimsy, humor or prank, or in anger or otherwise, contrary to the provisions of Section 1289.16 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
- Count 5: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Feloniously Pointing Firearm, a Felony, by unlawfully and willfully, without lawful cause pointed a rifle at Luis Salazar for the purpose of threatening or with the intention of discharging the firearm or with any malice or for any purpose of injuring, either through physical injury or mental or emotional intimidation or for purposes of whimsy, humor or prank, or in anger or otherwise, contrary to the provisions of Section 1289.16 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
- Count 6: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Feloniously Pointing Firearm, a Felony, by unlawfully and willfully, without lawful cause pointed a rifle at Eliseo Valentin Aiqui Cotom for the purpose of threatening or with the intention of discharging the firearm or with any malice or for any purpose of injuring, either through physical injury or mental or emotional intimidation or for purposes of whimsy, humor or prank, or in anger or otherwise, contrary to the provisions of Section 1289.16 of

Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

Count 7: On or about July 3, 2025, in Oklahoma County, Oklahoma, TONY RAMOS, did commit the crime of Feloniously Pointing Firearm, a Felony, by unlawfully and willfully, without lawful cause pointed a rifle at Carlos Enrique Aiqui Alonzo for the purpose of threatening or with the intention of discharging the firearm or with any malice or for any purpose of injuring, either through physical injury or mental or emotional intimidation or for purposes of whimsy, humor or prank, or in anger or otherwise, contrary to the provisions of Section 1289.16 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

I, **Detective Davin Boyett # 1822**, your Affiant, being first duly sworn, upon oath, depose and say:

Your affiant, **Detective Davin Boyett**, is a police officer employed by the City of Oklahoma City Police Department where I have been so employed since May of 2012. During my employment as a police officer, I have been assigned to the patrol division where I was responsible for investigating and enforcing federal, state, and city ordinances. I am currently assigned to the Investigations Bureau as a detective in the Assault Unit. Prior to being assigned to the Assault Unit, I was a detective in the Crimes Against Children Unit. With being assigned to the Assault Unit, I conduct follow-up investigations involving various crimes such as Assault & Battery, Assault & Battery with a Dangerous/ Deadly Weapon, Threatening Acts of Violence, Harassment/ Intimidation, and up to Homicide.

Your affiant has attended the City of Oklahoma Police Academy where I was trained in basic police procedures, basic criminal law, traffic enforcement, and municipal ordinances. I have attended specialized training for, but not limited to, investigating crime scenes, interview/interrogations, homicide investigations and child death investigations.

That the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person, are the following:

On Thursday, 07/03/2025, at approximately 0752 hours, OCPD patrol officers were dispatched to 1601 N. Purdue Ave. in Oklahoma City, Oklahoma County, Oklahoma 73127 in reference to a high priority A.D.W. call-for-service. This incident was later documented under OCPD case number 2025-0048542. Secondhand information was reported by a calling party that her husband had just witnessed a shooting and provided this address of the incident.

Several OCPD patrol officers arrived at this address and contacted several victims, to include Victim- A.A-C. (26 YOA). Information was reported that A.A-C. and several other victims (co-workers) arrived at this address earlier in the morning, around 0700 hours. During that time, Defendant- Tony Ramos (40 YOA), arrived in a white, 4-door, Cadillac Escalade.

Information was reported that Tony used to work with the victims but recently had a falling out. When Tony arrived, he asked A.A-C. to come work for him. Communication between A.A-C. and Tony became escalated. Tony was then seen going to his vehicle and selecting a pair of brass knuckles and confronting A.A-C. Tony then physically assaulted A.A-C. by striking him once in the mouth. A.A-C. attempting to get the brass knuckles away from Tony. Tony then goes back to his vehicle and retrieves two (2) handguns, carrying them in both of his hands. These handguns were described as semi-automatic handguns (one smaller and one full size) that are both black in color. A.A-C. attempts to take away one of the handguns away from Tony. During this time, Tony uses the other handgun and pistol whips A.A-C. in the head multiple times. Around this time, a passenger who was in Tony's vehicle contacts Tony and is able to take away the handguns from Tony. Tony then goes back to his vehicle and retrieves a black rifle. Tony contacts A.A-C. and several other victims and points the rifle at them. During this time, Tony shoots the rifle twice into the ground. Tony flees the scene with his firearms in the mentioned vehicle.

While on scene, officers observed A.A-C. to have visible injuries to his head. They also located two (2) spent rifle rounds and one (1) live 9mm ammunition round. Information was also learned that one of the victims had captured portions of this incident with their cellphone. This evidence located was consistent to what was reported. With information learned, Warr Acres Police Department was notified of the incident (due to Tony's listed address being in Warr Acres).

At approximately 0816 hours, a Warr Acres police officer located Tony's vehicle parked at his home which is located at 5953 NW 61st St. Tony and another male individual were located inside the Cadillac Escalade. The passenger surrendered and was taken into custody. However, Tony refused to exit the vehicle and barricaded himself in the vehicle for a while. Tony was seen trying to use a trash bag or something similar to conceal himself. Eventually, Tony exited the vehicle and went into the garage area of the home and further barricaded himself inside. Tony was given numerous commands to surrender but he refused. Because of Tony's actions and the information learned about this incident, this required a large Law Enforcement response by both Warr Acres Police Department and OCPD patrol officers and Tact Team officers.

Eventually, Tony was taken into custody at approximately 1002 hours. Due to the nature of the incident, detectives with the OCPD- Assault Unit were notified of the incident and responded to further this investigation. A detective responded and gathered statements from the victims. Contact with Tony was made; however, he refused to give a statement and requested an attorney. Tony was arrested for numerous felony charges to include Assault & Battery with a Dangerous Weapon, Felony Pointing Firearms, and Shooting with Intent to Kill.

The passenger (Witness- A.S., 22 YOA) that was taken into custody from Tony's vehicle by Warr Acres Police Department was interviewed. A.S. confirmed he contacted Tony earlier in the morning. Tony reported he was upset that he could not find anyone to work for him. Tony informed A.S. to stay at his home while he went to look for additional workers. Tony came back to A.S.'s later in the morning in the white Cadillac Escalade. After A.S. got into the vehicle, he noticed Tony was wiping blood from his chin area. Tony reported to A.S. that he was beaten up but did not go into details about what happened. Tony drove A.S. back to Tony's home.


Around that time, he noticed a police officer vehicle behind Tony's vehicle. Tony made the statement that he believed police were looking for him for some reason. When they arrived at Tony's home, Tony instructed him to open a side gate for him to pull his vehicle into the backyard. It was at that time, A.S. was taken into custody by police. A.S. said he witnessed Tony in possession of two (2) handguns in the vehicle, in the front right passenger seat in holsters. He described these firearms as a 1911 (handgun) grey or silver in color and another unknown black handgun.

During this investigation, I believe the above defendant, **Tony Ramos**, is in violation of **O.S. 21 § 645 Assault and Battery with Dangerous Weapon (2 counts)**, **O.S. 21 § 1289.16 Felony Pointing Firearms (5 counts)**, and **O.S. 21 § 652.A Shooting with Intent to Kill (1 count)**. I respectfully request an arrest warrant be issued for the above-named defendant.


