**Severance Agreement Between Employee and Oklahoma State Department of Education**

**Severance Agreement**

This Severance Agreement ("Agreement") is made and entered into on **October 13, 2025**, by and between **Todd Loftin** ("Employee") and the Oklahoma State Department of Education ("Employer").

**Recitals**

WHEREAS, Employee's employment with Employer will terminate effective **October 13, 2025**; and WHEREAS, Employer desires to provide Employee with severance pay, and Employee desires to accept such severance pay, in exchange for Employee's agreement not to sue or seek legal action against Employer;

**1. Severance Pay**

Employer agrees to pay Employee the Employee's regular salary, less applicable taxes and withholdings, through December 31, 2025. Details regarding distribution will be provided by human resources.

**2. Release of Claims**

In consideration for the severance pay described above, Employee agrees to fully and forever release and discharge the Oklahoma State Department of Education, its officers, employees, agents, and affiliates from any and all claims, demands, actions, or causes of action, whether known or unknown, that Employee may have arising out of or related to Employee's employment or termination of employment with Employer.

This release includes, but is not limited to, claims arising under federal, state, or local law, including any claim for wrongful termination, discrimination, harassment, retaliation, breach of contract, or any other employment-related claim.

**3. No Lawsuit Covenant**

Employee agrees not to file, pursue, or participate in any lawsuit, complaint, charge, or legal proceeding against Employer based on any claim released in Section 2 above.

**4. No Admission of Liability**

This Agreement does not constitute an admission of liability or wrongdoing by Employer or Employee.

**5. Confidentiality**

Employee agrees to keep the terms and existence of this Agreement confidential to the extent permitted by law, except as required by law or as necessary to enforce its terms.

**6. Entire Agreement**

This Agreement constitutes the entire agreement between the parties and supersedes any prior agreements or understandings, whether written or oral, relating to Employee's employment and separation.

**7. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of Oklahoma.

**8. Voluntary Agreement**

Employee acknowledges that Employee has read and understands this Agreement, has had the opportunity to consult with legal counsel, and signs this Agreement voluntarily and without coercion.
